Grand President's Report – Georgette Boulegeris, GP, addressed the DOP delegation speaking about her 50 visitations in 52 weeks. She shared 5 important points to go by: 1. Have fun. 2. Be with a winning team. 3. Be professional. 4. Do not stress out. 5. Always honor the DOP. She attended the Greece Conference, which was in Crete and while there, boarded a warship. She visited the Patriarchate and Cyprus, and Capitol Hill Day was something special. For the second year in a row the Daughters of Penelope saw an increase of over 1000 members and GP Georgette congratulated GVP Marianthi for her enthusiasm for Growth & Expansion. The National Charity Walk raised more than \$2,000 for the DOP Charitable Foundation. The Spirit of Penelope Award was created and the first was presented at the Zone 1 Conference in March 2023. The Power of WE mail campaign raised \$8,000 net. GP Georgette reached out to people asking for donations and received over \$30,000. Her recommendations were the establishment of a permanent obligation to support the 3 charities bearing the DOP name, and the creation of a committee to investigate the feasibility of a DOP Board of Trustees. She thanked everyone who donated to the Power of WE campaign, and everyone who participated in the National Charity Walk. She congratulated and thanked the Ad Hoc Committee.

 Evellyn Tsiadis, PGP, District 5, Tethys 229, moved to accept the Grand President's report and for the recommendations to go to the proper committee.

**Growth & Expansion Report** – Marianthi Treppiedi, GVP, announced that her motto this year was INVITE, INVOLVE, INVEST. The DOP surpassed last year's 1000-member growth, growing by over 1100 members. Five new Chapters were chartered and two were reactivated. GVP Marianthi thanked Executive Director Elena Saviolakis for all her amazing work, and she announced the Growth & Expansion Award Recipients:

The Convention Chairman declared the Growth & Expansion report accepted without objection.

**DOP Foundation, Inc.** – Anna-Helene Grossomanides, PGP, DOP Foundation, Inc. President, introduced the current Board of Directors and read out a letter from Sonja Stefanadis, PGP, and Foundation President Emeritus. The Foundation investments are over \$1,000,000. This is the first year that scholarships were given to both women and men, in total \$39,000. The Foundation would not be presenting for National Projects. *The Bridges Grant Initiative Program* would increase from \$250 to \$500 as of this convention. At the Foundation table there would be books and other items for sale as well as a used book exchange. This year the Foundation is celebrating its  $40^{th}$  anniversary. Gift bags were given to all in attendance, and the Foundation is sponsoring coffee and cake on Thursday, July 27.

The Convention Chairman declared the DOP Foundation, Inc. report accepted without objection.

DOP Headquarters Report – Elena Saviolakis, Executive Director, summarized her report from the yearbook. She thanked all the DOP, her Headquarters co-workers, the Grand Lodge, AHEPA, and AHEPA Board of Trustees. Sister Elena presented a PowerPoint on the 2022 District Governors Leadership Conference presentation materials which is available on the national website. Headquarters had sent e-packages to all chapters for consolidated convenience. She spoke about the Headquarters social media accounts on Twitter, Facebook, and Instagram, about the DOP website, as well as articles in the National Herald. She encouraged chapters to have a social media presence and said most already have a Facebook or Instagram account. She mentioned the beautiful flyer created by Penelope's Scroll editor Sister Angeliki Frangos and announced that almost 1000 stories have been collected for the Oral History Project, with Founders Day 2023 as its completion target. Sister Elena also spoke about Grand President Georgette Boulegeris, mentioning her work throughout the year, her travels, and her initiatives.

The Convention Chairman declared the DOP Headquarters report accepted without objection.

Sister Elena informed the delegation that Carl Hollister, PSP, wasn't present and the DOP Investment Report would be given at a later date.

Barbara Stavis Wolf, PGP, District 16, Nestor 55, presented the Ad Hoc committee report.

Barbara Stavis Wolf, on behalf of the Ad Hoc Committee, recommended the following revisions to the Ritual and moved that they be accepted:

1. Wherefore, in order to streamline, condense, shorten and simplify the procedure for meetings and ceremonies, certain appointed officers will be eliminated, with the President allowed to appoint those needed to properly conduct meetings, and allow meetings to take place in smaller venues with a more contemporary set-up;

## NOW THEREFORE BE IT RESOLVED THAT:

The book be called BOOK OF PROCEDURES and the recommended chapter meeting and ceremony procedure shall be set forth below, with Chapters having the option to have members appointed to handle certain tasks during each meeting OR the chapter may determine to have members appointed by the President for those duties for the entire year.

and BE IT FURTHER RESOLVED THAT: The President shall have the option as determined by the chapter to appoint members to read the prayers and conduct escorting at meetings only as needed. The Chapters shall also have the option to follow the new recommended meeting

diagram or Chapters may select alternative seating arrangements for meetings as they deem appropriate. The duties of handling paraphernalia and checking membership at meetings may be assigned to the Vice President or another member who will assist the Vice President with those tasks.

and BE IT FURTHER RESOLVED THAT: the wording used for the meetings and ceremonies shall be mandatory, but the chapters shall have flexibility in the setup of the meeting room and the assigned members to handle certain parts of the meetings and ceremonies.
